# **DISCOVERY PHASE**



Initial Consultation

This is where we take the time to understand you, your style, and the vision you have for your project.

Design Service Proposal After our initial meeting, our team collects all the necessary details to provide a flat fee quote. See a sample proposal in the next section

Contract Execution

Once the final proposal details are confirmed, contract execution is required to move forward into the design phase.
